

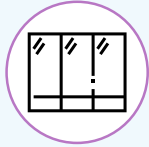
# Required Regulations for Maintaining Public Health Restaurants & Cafes



Take-away and delivery is permitted



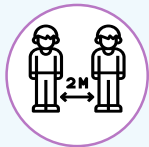
Seating is not allowed



A partition must be placed between the employee and customer



The employer must group together separate shifts with the same employees together for each shift



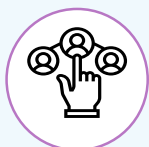
There must be 2 meters between people



There must be adherence to strict hygiene rules including consistent disinfection of surfaces.



Employees must wear masks and gloves



Employees must regulate entrance of customers, and allow no more than 2 customers per register, and if the store is larger than 100 metres, no more than 4 customers per register



Employees must ensure that no person enters the store unless they are wearing a mask. A sign must be placed instructing customers to wear masks, and a customer not wearing a mask may not receive service



A sign must be placed in a visible location instructing to maintain proper distance and the allowed number of customers

## Required Regulations for Maintaining Public Health

# Stores:



The store owner must submit a signed declaration to the local authority before opening that they will follow the regulations



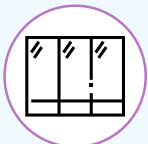
Employees must ensure, to the best of their ability, measurement of temperature and possible symptoms of customers before they enter the store



The employer must group together separate shifts with the same employees together each shift



The employer must appoint an employee responsible for ensuring the following of the regulations



A partition must be placed between the employee and customer



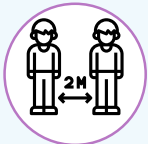
Employees must regulate entrance of customers, and allow no more than 2 customers per register, and if the store is larger than 100 metres, no more than 4 customers per register. Employees will establish and operate a mechanism for restricting entry into the store



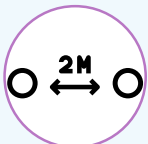
There must be adherence to strict hygiene rules including consistent disinfection of surfaces.



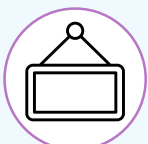
Employees must ensure that no person enters the store unless they are wearing a mask. A sign must be placed instructing customers to wear masks, and a customer not wearing a mask may not receive service



There must be 2 meters between people, and the employees must prevent gathering in one area



Spaces must be marked 2 meters apart for those waiting in the queue



A sign must be placed in a visible location instructing to maintain proper distance and the allowed number of customers



Employees must wear masks

# Required Regulations for Maintaining Public Health Hairdressers, Beauty Salons, & Cosmetic Services



The store owner must submit a signed declaration to the local authority before opening that they will follow the regulations



Employees must ensure, to the best of their ability, measurement of temperature and possible symptoms of customers before they enter the store



The employer must group together separate shifts with the same employees together each shift



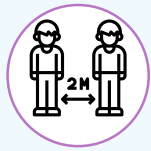
There must be adherence to strict hygiene rules including consistent disinfection of surfaces, equipment, chairs / beds, and changing of towels between customers and washing towels between uses



Gloves must be worn and switched between customers



The staff must wear masks, and face-shields covering the eyes.



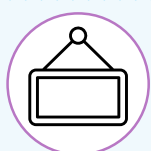
There must be 2 meters between people and a sign must be placed instructing this



The business owner will ensure that all those entering wear a mask. A sign must be placed regarding the requirement of wearing a mask and prohibition of serving customers not wearing a mask



The staff must regulate entrance of customers, and allow no more than 2 customers per employee, and no more than 4 customers in the store. In a store larger than 75 meters squared, there may not be more than 6 customers at a time. In a store larger than 100 meters squared, there may not be more than 8 customers at a time  
Employees will establish and operate a mechanism for restricting entry into the store



A sign must be placed in a visible location regarding the allowed number of customers
