And for the first time, there will also be a forum for pre-arranging networking meetings during the conference.

Building on the success of past conferences, we expect a diverse audience of over 400 participants from Blue Chip companies, VC's, angel-investors, policy makers, technology commercialization professionals, and entrepreneurs
